The ISOSWO Awards Program recognizes premier facilities, projects, programs and individuals in the Iowa solid waste management industry with some well-deserved accolades.

The award nomination process is easy, simply complete the attached forms and return them to the Awards Committee Chairperson, Bill Rowland **by Wednesday, July 31, 2019**. The ISOSWO Awards Committee will review all nominations and make its recommendations to the ISOSWO Board of Directors at the Board's August meeting.

Those receiving awards will be notified by mid-August. The awards will be formally presented at the ISOSWO/IRA Fall Conference to be held in Dubuque September 30 – October 2, 2019.

Award recipients will also have an opportunity to be selected for a two to three-minute professional video produced highlighting the award-winning facility, project, or individual. The Awards Committee will consider all selected award applicants and recommend to the ISOSWO Board of Directors one that they believe stands above the rest and that can be effectively communicated through a video. The Awards Committee will announce the video production winner during the ISOSWO/IRA Fall Conference award ceremony. The Awards Committee will work with the selected award recipient to produce the video to be shown at the Spring ISOSWO Conference. See page 3 for additional information.

Video Production Award:

In addition to being selected to receive one of the awards above, the Awards Committee will work with the selected applicant to develop and produce a two to three-minute professional video about their award-winning facility, project, or individual. The video will provide the recipient a means to help promote and communicate the outstanding and/or innovative project, facility, or individual. The completed video will be premiered at the ISOSWO Spring Conference, posted on the ISOSWO website, and provided to the award recipient for their use.

The video award recipient may be asked to provide an on-camera interview, additional high-quality photos, and access to film locations/activities depicting the awarded facility, project, or individual. The recipient will be provided with a rough-cut of the video to provide comments before final production is complete. The Awards Committee will work with the award recipient to produce the video to be shown at the Spring ISOSWO Conference.

AWARDS SCORING CRITERIA (FACILITIES/PROGRAMS/PROJECTS):

A purpose of the ISOSWO Awards Program is to recognize facilities, programs and projects within the solid waste management industry of Iowa that represent excellence. The ISOSWO Board of Directors has established selection criteria by which nominated facilities, programs or projects are to be evaluated. The following are the criteria and maximum point values for which nominations will be judged. Nominations should address each criterion specified. No points will be assigned if that category is not addressed.

- 1) Application Completeness: 5 points**
 - * Has all required information been included?

- 2) Innovation/Creativity/Excellence: 20 points**
 - * Describe the innovative, creative and/or excellent aspects of the facility/program/project.
 - * Does the facility/program/project advance the Iowa solid waste management industry?

- 3) Customer Service: 10 points**
 - * Was the facility/program/project designed and/or carried out with community benefits in mind?
 - * Does the community regard the facility/program/project as positive?

- 4) Cost Effectiveness: 20 points**
 - * Discuss how the facility/program/project has performed relative to its cost.
 - * Are the economics successful compared to those found elsewhere in the Iowa solid waste management industry?

- 5) Performance: 20 points**
 - * Describe how efficiently the facility/program/project performs.
 - * Does the facility/program/project do what it was intended to do?
 - * Does the performance of the facility/program/project meet or exceed its established goals and expectations?

- 6) Environmental Benefits: 25 points**
 - * Describe the environmental benefits of the facility/program/project.
 - * Discuss overall impact of the facility/program/project on human health, environmental quality and resource conservation.
 - * Has the facility/program/project achieved its purpose (if so intended) for environmental compliance?

AWARDS SCORING CRITERIA (PROFESSIONAL ACHIEVEMENT):

The other equally-important purpose of the ISOSWO Awards Program is to recognize persons within the solid waste management industry of Iowa who have demonstrated excellence. The ISOSWO Board of Directors has established selection criteria by which nominated persons are to be evaluated. The following are the criteria and maximum point values for which nominations will be judged. Nominations should address each criteria specified. No points will be assigned if that category is not addressed.

- 1) Application Completeness: 5 points**
 - * Has all required information been included?

- 2) Innovation/Creativity/Excellence of Work: 25 points**
 - * Describe the innovative, creative and/or excellent aspects of the person.
 - * How well does the person advance and/or represent the Iowa solid waste management industry?

- 3) Customer Service: 30 points**
 - * Does the person have a “customer first” attitude?
 - * Provide examples of how the person interacts with customers in a positive manner.

- 4) Respect Among Co-Workers: 20 points**
 - * Provide examples that demonstrate that the person is respected/valued by his or her co-workers.

- 5) Respect of Peers: 20 points**
 - * Provide examples that demonstrate that the person is respected/valued by his or her ISOSWO peers.
